**PROPOSAL II—2012 BUDGET TAX LEVY**

Shall the 2012 annual budget for the Commissioners of Fire District No. 1 in the Township of Hopewell in the County of Mercer, New Jersey be approved in the sum of \$3,087,817, of which \$2,670,075 will be raised by taxation?

**PROPOSAL III—FIRE DISTRICT BONDS**

Shall the Commissioners of Fire District No. 1 in the Township of Hopewell in the County of Mercer, New Jersey be authorized: (i) to purchase self-contained breathing apparatuses and an emergency radio system in order to interact and with the County of Mercer and other entities; (ii) to appropriate \$750,000 for such acquisitions funded, in part, by a \$371,000 grant for the emergency radio system from the “Federal Emergency Management Agency” (commonly known as “FEMA”); and (iii) to issue bonds of the Fire District in the principal amount of \$379,000 for such purposes?
