		Shall the Commissioners of Fire District No. 1 in the Township of Hopewell in the County of Mercer, New Jersey be approved to authorize the repayment over ten years to the Pennington Borough Fire District of 76% of the final cost of a replacement Ladder Truck with a purchase price not to exceed \$1,250,000.00 for the use by the Pennington Borough Fire District / Pennington Fire Company that will be used to respond to fire calls within Hopewell Township?

EXPLANATORY STATEMENT

A yes vote will authorize the Hopewell Township Board of Fire Commissioners to obligate and raise over 10 years by taxation and pay 76% of the purchase price of a replacement ladder truck. The purchase price of the Ladder Truck will not exceed \$1,250,000.00. The Ladder Truck will replace a 21-year-old ladder truck and will be utilized by the Pennington Borough Fire District / Pennington Fire Company to respond to emergency incidents within Hopewell Township. The percentage amount of repayment is from an Agreement for Primary Fire Protection between the Hopewell Township Fire District and the Pennington Borough Fire District. It is anticipated that this expense will have a \$0.003 of a cent affect annually on the tax rate.
