

The 2024 proposed budget has a modest overall increase of 2.3% in spite of seeing an increase in capital appropriations needed to sustain our emergency response operations. This was also completed in an effort to reduce our fund balance surplus usage to balance the budget. An increase in revenue from fees contributed to the reduction of fund balance usage.

As stated above, the utilization of fund balance to balance the budget saw a decrease in usage by 17.97% (\$117,857.68) due to in part the anticipated increase in fees of \$79,273.04 year over year that saw an overall increase in total anticipated revenues of \$78,412.04. An additional increase from 2023 is the deferred charge of \$30,000 through an emergency appropriation for a used fire truck. A reduction of LOSAP in the budget of 12.6% is realized due to the shutting down of one of the volunteer first aid squads. An increase can be seen in capital appropriations for an emergency response/fire inspection vehicle to be purchased in 2024.

If Unrestricted Fund Balance is reduced by more than 10%, explain the projected impact on the following year's budget.

The amount to be raised by taxation in the proposed 2024 budget will increase by \$156,889.56 in comparison to the 2023 budget causing the tax rate per \$100.00 of assessed valuation to increase to \$0.1153. The Fire District will utilize \$537,947.51 of Unrestricted Fund Balance to remain within the 2% Levy Cap. The Commissioners will continue to strictly oversee the budget to ensure compliance and funding availability. Fire prevention and protection of the citizens and property owners of Hopewell Township will be the main focus of the Fire Commissioners.
