**A RESOLUTION OF THE TOWNSHIP OF HOPEWELL, IN THE COUNTY OF
MERCER, STATE OF NEW JERSEY, AUTHORIZING TOWNSHIP OF
HOPEWELL CHANGE ORDER #1 TO BID # 22-06 SALT BARN PROJECT**

WHEREAS, the Township of Hopewell awarded Bid # 22-06 Salt Barn Project through resolution #22-157 to RNM Construction, in the amount of \$747,000.00; and

WHEREAS, the design engineers Van Cleef Engineering, have concluded the change order is necessary to add pumping of contaminated ground water into frac tank, adds admixture to footing concrete to protect against salt deterioration and takes credit for decrease excavation due to grading change to limit amount of contaminated soil removed from the site. and

WHEREAS, the amount of change order is a minor modification and represents a \$1,849.50 (.25%) increase in the contract amount, giving the new contract amount as follows:

WHEREAS, in accordance with N.J.A.C. 5:30-11.3, the change order has not caused the originally awarded contract price to be exceeded by more than 20 percent; and

WHEREAS, the Chief Financial Officer certifies funding is available from:

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Hopewell, in the County of Mercer and State of New Jersey, that it authorizes a written amendment in the form of Change Order #1 in the amount of an increase of 0.25% (\$1,849.50) for a total contract price of \$748,849.50 due to the unforeseen required services in the enactment of bid #22-06 Salt Barn Project.

This resolution will take effect immediately upon its passage.
