**RESOLUTION TO AWARD BID TO NATIONAL WATER MAIN CLEANING  
COMPANY FOR BID 23-06, SANITARY SEWER SYSTEM REHABILITATION**

**WHEREAS** the Township of Hopewell has a need for rehabilitation for sanitary sewer system, for the daily Municipal Operations; and

**WHEREAS**, the Township had sought to obtain a vendor through bid 23-06, publicly advertised, received and opened on May 17, 2023 at 9:00 A.M. in a fair and open manner consistent with N.J.S.A. 19:44A-20.5; and

**WHEREAS** the Township received three (3) bids to wit:

**WHEREAS** the bid by National Water Main Cleaning Company, 1805 Newark Turnpike, Kearny, New Jersey, 07031 has been determined to be the lowest responsible bid, confirmed by the Township Engineer, Design Engineer and Qualified Purchasing Agent, in accord with N.J.S.A. 40A:11-4A, in the amount of base bid and supplemental bids of \$833,357.93; and

**WHEREAS** the Chief Financial Officer certifies funding is available in the amount of \$833,357.93 from X-08-00-428-540.

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Hopewell, in the County of Mercer as follows:


National Water Main Cleaning Company, 1805 Newark Turnpike, Kearny, New Jersey, 07031 is hereby awarded Bid 23-06 for provision of sanitary sewer system rehabilitation in the amount of \$833,357.93, consistent with the tenets as found within Bid 23-06; and
