**A RESOLUTION AUTHORIZING  
PROFESSIONAL SERVICES AGREEMENTS**

**WHEREAS**, there exists a need for professional services for the following: Engineering services related to the bid and construction phase of the Sanitary Sewer System Rehabilitation Project in the Stony Brook Sewer Utility; Engineering services related to various capital projects approved in the 2023 capital program (2023 Road program, 2023 Road Maintenance Program, NJDOT Project on Pennington-Rocky Hill Road); and

**WHEREAS**, the estimated cost of the contract is not to exceed \$88,500.00 for Engineering Services related to the bid and construction phase of the Sanitary Sewer System Rehabilitation Project in the Stony Brook Sewer Utility (X-08-00-428-520); \$332,000.00 for Engineering services related to the various capital projects approved in the 2023 capital program (X-04-00-685-312); and funds are available for this purpose certified by the local finance officer as encumbered in the accounts referenced above; and

**WHEREAS**, the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.) requires that a resolution authorizing the award of contracts for "Professional Services" without competitive bids and the contract itself must be available for public inspection.

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Hopewell, as follows:

1. The Mayor and Clerk are hereby authorized and directed to execute the attached agreement with:

Suburban Consulting Engineers Inc for Engineering Services  
Van Cleef Engineering Associates for Engineering Services

2. The contracts are awarded without competitive bidding as a "Professional Service" under the provisions of the Local Public Contracts Law N.J.S.A. 40A:11-5 (1)(a) as a contract for services to be performed by persons authorized by law to practice recognized professions that are regulated by law and it is not possible to obtain competitive bids.

3. A notice of this action shall be published once in the official newspaper as required by law.
