### **NOTICE OF HEARING ON AMENDMENT TO ZONING ORDINANCE**

On June 12, 2023, the Hopewell Township Committee introduced an Ordinance entitled:

**“ORDINANCE OF THE TOWNSHIP OF HOPEWELL AMENDING CHAPTER 24 “CANNABIS” AND CHAPTER 17 “LAND USE AND DEVELOPMENT” OF THE CODE OF THE TOWNSHIP OF HOPEWELL TO PERMIT AS A CONDITIONAL USE CLASS II CANNABIS MANUFACTURING IN THE SPECIAL INDUSTRIAL ZONING DISTRICT.”**

This Ordinance, if adopted, would permit cannabis manufacturing as a conditional use in the Special Industrial (SI) zoning district. The conditional use requirements for a cannabis manufacturing facility would include (a) licensing, (b) location at least 1000 feet from schools, school playgrounds and school athletic fields, (c) architectural drawings that show compliance with all requirements, and (d) no onsite consumption or use of cannabis, no cannabis product or product images displayed or visible, all products stored indoors, and no display or onsite advertisement of products. The Ordinance would also specify hours of operation, parking and loading, site access, odor control, signage, security, and lot, yard, height and coverage requirements.

The SI district is bounded by Route 31 on the east, the municipal boundary on the south, the Conrail railroad tracks on the west, and Reed Road to Diverty Road on the north.

**PLEASE TAKE NOTICE** that a public hearing on the Ordinance will be held at the Hopewell Township Committee meeting on **August 21, 2023 at 6:30 p.m.** at the **Hopewell Township Municipal Building**, 201 Washington Crossing-Pennington Road, Titusville, NJ 08560, at which time the Township Committee will consider the Ordinance for adoption.
