**RESOLUTION TO AWARD BID TO EARLE ASPHALT COMPANY FOR BID
#23-12, PENNINGTON ROCKY HILL ROAD IMPROVEMENTS**

WHEREAS the Township of Hopewell has a need for road improvements to Pennington Rocky Hill Road; and

WHEREAS, the Township had sought to obtain a vendor through bid #23-12, publicly advertised, received and opened on October 17, 2023, at 12:00P.M. in a fair and open manner consistent with N.J.S.A. 19:44A-20.5; and

WHEREAS the Township received four (4) bids to wit:

WHEREAS the bid by Earle Asphalt Company, 1800 Route 34, Building 2, Suite 205, Wall, N.J., 07719 has been determined to be the lowest responsible bid, confirmed by the Township Engineer, Design Engineer and Qualified Purchasing Agent, in accord with N.J.S.A. 40A:11-4A, in the amount of base bid of \$498,713.13; and

WHEREAS, this project is partially funded by the New Jersey Department of Transportation and subject to their approval; and

WHEREAS the Chief Financial Officer certifies funding is available in the amount of \$498,713.13 from X-02-00-920-230.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Hopewell, in the County of Mercer as follows:


Subject to the approval by the New Jersey Department of Transportation, Earle Asphalt Company, 1800 Route 34, Building 2, Suite 205, Wall, N.J., 07719 is hereby awarded Bid #23-12 for road improvements to Pennington Rocky Hill Rd in the amount of \$498,713.13, consistent with the tenets as found within Bid #23-12; and

BE IT FURTHER RESOLVED, the Mayor is authorized to execute all agreements and documents in furtherance of award of Bid #23-12.
