**"RESOLUTION TO AUTHORIZE THE AWARD OF A REQUIRED
DISCLOSURE CONTRACT WITH INTERMEDIA.NET FOR TELEPHONIC
COMMUNICATIONS SERVICES"**

WHEREAS, the Township of Hopewell has a need for telephone communications in its operations as a required disclosure contract pursuant to the provisions of N.J.S.A. 19:44A-20.4; and,

WHEREAS the police department has received several quotes in accord with N.J.S.A.40A:11-1 et. Seq., with Intermedia.net, Inc being the most advantageous price and other factors; and

WHEREAS, Intermedia.net, Inc, 825 East Middlefield Rd, Mountain View, CA 94043, in the aggregate is expected to be in excess of the play threshold of \$17,500.00 as well as bid threshold over the 36 month contract; and

WHEREAS, Intermedia.net, Inc, 825 East Middlefield Rd, Mountain View, CA 94043 is exempt from the bid threshold mandate as the service is regulated by the Federal Communications Commission in accord with N.J.S.A.40A:11-5(f); and

WHEREAS, Intermedia.net, Inc, 825 East Middlefield Rd, Mountain View, CA 94043 has completed and submitted a Business Entity Disclosure Certification and a Personal Contribution Disclosure form which certifies that Intermedia.net, Inc, 825 East Middlefield Rd, Mountain View, CA 94043 has not made any reportable contributions to a political or candidate committee in the Township of Hopewell in the previous one year, and that the contract will prohibit Intermedia.net, Inc, 825 East Middlefield Rd, Mountain View, CA 94043 from making any reportable contributions through the term of the contract, and

WHEREAS subject to the future approving of the municipal budget by the governing body of the Township of Hopewell the Chief Financial Officer hereby certifies that funds NOT TO EXCEED an aggregate over 36 months of \$90,000.00 are available as follows.


