**AUTHORIZE THE AWARD OF A REQUIRED DISCLOSURE CONTRACT WITH
“KULAK ARMS AND OUTFITTERS LLC” FOR
POLICE UNIFORMS AND ACCESSORIES**

WHEREAS, the Township of Hopewell has a need for police uniform and accessories service for the daily operations of the Township of Hopewell Police Department supplied by Kulak Arms and Outfitters LLC, 415 Lawrence Rd., Lawrenceville, N.J. 08648, as a required disclosure contract pursuant to the provisions of N.J.S.A. 19:44A-20.5; and

WHEREAS, Kulak Arms and Outfitters LLC in the aggregate is expected to be in excess of the play threshold of \$17,500.00; and

WHEREAS, Kulak Arms and Outfitters LLC, has completed and submitted a Business Entity Disclosure Certification and a Personal Contribution Disclosure form which certifies that Kulak Arms and Outfitters LLC has not made any reportable contributions to a political or candidate committee in the Township of Hopewell in the previous one year, and that the contract will prohibit Kulak Arms and Outfitters LLC from making any reportable contributions through the term of the contract; and

WHEREAS, the Chief Financial Officer hereby certifies that funds are available in the 2023 budget year in the amount of \$25,000.00 (3-01-25-240-043) and will be included in the 2024 budget year in the amount of \$35,000.00 (4-01-25-240-043).

NOW, THEREFORE, BE IT RESOLVED, that the Township Committee of the Township of Hopewell authorizes the police department to procure from Kulak Arms and Outfitters LLC, 415 Lawrence Rd., Lawrenceville, N.J. 08648 police uniforms and accessories and not to exceed \$25,000.00 in the budget year 2023 and \$35,000.00 in the budget year 2024; and

BE IT FURTHER RESOLVED, that the Business Disclosure Entity Certification and Personal Contribution Disclosure form, Determination of Value be placed on file with this resolution.
