**RESOLUTION TO AWARD BID TO DOWN TO EARTH LANDSCAPING FOR BID #
23-11, 2023 FOX RUN EASEMENT MAINTENANCE IN FAIR AND OPEN MANNER**

WHEREAS, the Township had sought to obtain a vendor through Bid #23-11, publicly advertised, received and opened on November 30, 2023, at 10:00A.M. in a fair and open manner consistent with N.J.S.A. 19:44A-20.5; and

WHEREAS the bid by Down to Earth Landscaping Inc., 705 Wright Debow Road, Jackson, New Jersey, 08527 has been determined to be the lowest responsible bid, confirmed by the Township Engineer, Design Engineer and Qualified Purchasing Agent, in accord with N.J.S.A. 40A:11-4A, in the amount of base bid of \$170,733.90; and

WHEREAS the Chief Financial Officer certifies funding is available in the amount of \$170,733.90 from X-04-00-677-540.

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Hopewell, in the County of Mercer as follows:

Down to Earth Landscaping Inc., 705 Wright Debow Road, Jackson, New Jersey, 08527 is hereby awarded Bid # 23-11 Fox Run Easement Maintenance in the amount of \$170,733.90, consistent with the tenets as found within Bid #23-11; and
