**A RESOLUTION ESTABLISHING A  
TEMPORARY CAPITAL BUDGET**

**WHEREAS,** The Township of Hopewell desires to establish the 2024 Temporary Capital Budget; and

**WHEREAS,** N. J.A.C. 5:30-4.4B provides for the adoption of a temporary capital budget when it is desired to approve capital projects prior to adoption of the capital budget;

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Hopewell, County of Mercer, State of New Jersey, that the following temporary 2024 capital budget be adopted:
