**RESOLUTION OF SUPPORT FOR THE COUNTY OF MERCER TO ESTABLISH
SPEED LIMITS ALONG HOPEWELL-PENNINGTON ROAD/WEST BROAD STREET
(CR 654) BETWEEN N.J. ROUTE 31 AND LOUELLEN STREET (CR 518), HOPEWELL
TOWNSHIP, HOPEWELL BOROUGH, MERCER COUNTY**

WHEREAS, Mercer County Board of County Commissioners is desirous of passing an Ordinance setting speed limits along Hopewell-Pennington Road/West Broad Street (CR 654) Between N.J. Route 31 And Louellen Street (CR 518), Hopewell Township, Hopewell Borough, Mercer County; and

WHEREAS, the speed limits for both directions of traffic along Hopewell-Pennington Road / West Broad Street (County Route 654) BETWEEN N.J. Route 31 AND Louellen Street (County Route 518), Hopewell Township, Hopewell Borough, Mercer County, are to be established as follows:

Zone 1: 40 MPH between N.J. Route 31 and a point 250 feet west of the center line of Moore's Mill-Mount Rose Road; thence

Zone 2: 35 MPH between a point 250 feet west of Moore's Mill-Mount Rose Road and the Hopewell Township-Hopewell Borough Corporate Line; thence

Zone 3: 25 MPH between the Hopewell Township-Hopewell Borough Corporate Line and Louellen Street (County Route 518); and

WHEREAS, the County of Mercer requires a resolution of support from affected municipalities in order to adopt such ordinance.

NOW, THEREFORE BE IT RESOLVED, by the Township Committee of the Township of Hopewell, County of Mercer, State of New Jersey, that the Township Committee hereby supports a Mercer County ordinance establishing speed limits along Hopewell-Pennington Road/West Broad Street (CR 654) between N.J. Route 31 and Louellen Street (CR 518), Hopewell Township, Hopewell Borough, Mercer County.
