THE CONTRACT FOR BID #23-06 SANITARY SEWER SYSTEM
REHABILITATION**

WHEREAS, the Township of Hopewell awarded Bid #23-06 to National Water Main Cleaning Company, through Resolution 23-226 on June 12, 2023, in the aggregate amount of \$833,357.93; and

WHEREAS, there is a need for additional quantities of Pay Item #10 - Manhole Frame and Cover Replacements, representing a net increase of \$3,725.00 in the contract amount, and

WHEREAS, pursuant to the design engineer's recommendation, it is recommended that this change order be allowed; and


WHEREAS, in accordance with N.J.A.C. 5:30-11.3, the change order has not caused the originally awarded contract price to be exceeded by more than 20 percent; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Hopewell, in the County of Mercer and State of New Jersey, that it authorizes a written amendment in the form of Change Order # 1 in the amount of a net increase of \$3,725.00 for a total contract price of \$837,082.93 to National Water Main Cleaning Co. for bid #23-06 Sanitary Sewer System Rehabilitation in accordance with N.J.A.C. 5:30-11.1 et. Seq.,


