**WHEREAS**, there exists a need for professional services related to various engineering projects for the Township; and

**WHEREAS**, Van Cleef Engineering Associates, LLC, has provided for a quotation for services without bidding as per N.J.S.A. 40A:11-5(1)(a)(i); and

**WHEREAS**, the Township has procured Van Cleef Engineering Associates, LLC in a non-fair and open manner in accord with N.J.S.A.19:44A-20.5; and

**WHEREAS**, Van Cleef Engineering Associates, LLC, has provided for a Business Entity Disclosure and Political Contribution Disclosure in accord with N.J.S.A.19:44A-20.5 indicating Van Cleef Engineering Associates, LLC has not made any reportable contributions in the past 12 months and will be prohibited from making reportable contributions in the coming year; and

**NOW, THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Hopewell, as follows:


1. The Mayor and Clerk are hereby authorized and directed to execute the agreement with Van Cleef Engineering Associates, LLC for annual engineering services.
