**A RESOLUTION OF THE TOWNSHIP OF HOPEWELL, IN THE COUNTY OF  
MERCER, STATE OF NEW JERSEY, AUTHORIZING TOWNSHIP OF  
HOPEWELL CHANGE ORDER #2 TO BID # 22-06 SALT BARN PROJECT**

**WHEREAS**, the Township of Hopewell awarded Bid # 22-06 Salt Barn Project through resolution #22-157 to RNM Construction, in the amount of \$747,000.00; and

**WHEREAS**, on April 23, 2023, Resolution 23-170 was passed to approve change order number one in the amount of \$1,849.50 amending the contract amount to \$748,849.50; and

**WHEREAS**, it has been determined that change order number two is necessary to reflect changes to the scope of the project that were unforeseen at the time of public bidding:

<b>Percent Increase from Original Contract</b>	<b>3.32%</b>

**WHEREAS**, in accordance with N.J.A.C. 5:30-11.3, the change order has not caused the originally awarded contract price to be exceeded by more than 20 percent; and


**WHEREAS**, the Chief Financial Officer certifies funding in the amount of \$22,983.01 is available from budget account line item X-04-00-675-615.
