**A RESOLUTION AUTHORIZING THE AWARD OF A REQUIRED DISCLOSURE
CONTRACT WITH DAVE MULLER AUTOMOTIVE AND TRAILER, FOR
DEPARTMENT OF PUBLIC WORKS TRAILERS**

WHEREAS, the Township of Hopewell Department of Public Works has a need for trailers and accessories in its daily operations supplied by Dave Muller Automotive & Trailer, 1383 Lower Ferry Rd., Ewing, NJ. 08618, as a required disclosure contract pursuant to the provisions of N.J.S.A. 19:44A-20.5; and,

WHEREAS, Dave Muller Automotive & Trailer, 1383 Lower Ferry Rd., Ewing, NJ. 08618, has completed and submitted a Business Entity Disclosure Certification and a Personal Contribution Disclosure form which certifies that Dave Muller Automotive & Trailer, 1383 Lower Ferry Rd., Ewing, NJ. 08618 has not made any reportable contributions to a political or candidate committee in the Township of Hopewell in the previous one year, and that the contract will prohibit Dave Muller Automotive & Trailer, 1383 Lower Ferry Rd., Ewing, NJ. 08618 from making any reportable contributions through the term of the contract, and

WHEREAS, the Chief Financial Officer hereby certifies that funds NOT TO EXCEED \$35,910.52 are available as follows.


