**RESOLUTION TO AUTHORIZE THE AWARD OF A REQUIRED DISCLOSURE  
CONTRACT WITH " PELLEGRINO CHEVROLET" FOR 2024 CHEVROLET  
EQUINOX**

**WHEREAS**, the Township of Hopewell has a need for administrative/ fleet vehicles for the daily operation of the Township supplied by Pellegrino Chevrolet, 1000 Gateway Blvd, Westville, NJ 08093, as a required disclosure contract pursuant to the provisions of N.J.S.A. 19:44A- 20.5; and

**WHEREAS**, Pellegrino Chevrolet, has supplied a quote in the amount of \$29,930.00, in excess of the pay to play threshold of \$17,500.00; and

**WHEREAS**, the Township has complied with N.J.S.A.40A:11-6.1 in obtaining multiple quotes; and

**WHEREAS**, Pellegrino Chevrolet, 1000 Gateway Blvd, Westville, NJ 08093, has completed and submitted a Business Entity Disclosure Certification and a Personal Contribution Disclosure form which certifies that Pellegrino Chevrolet, 1000 Gateway Blvd, Westville, NJ 08093 has not made any reportable contributions to a political or candidate committee in the Township of Hopewell in the previous one year, and that the contract will prohibit Pellegrino Chevrolet, 1000 Gateway Blvd, Westville, NJ 08093 from making any reportable contributions through the term of the contract; and

**WHEREAS** the Chief Financial Officer hereby certifies that funds NOT TO EXCEED \$29,930.00 are available as follows:
