**A RESOLUTION OF THE TOWNSHIP OF HOPEWELL, IN THE COUNTY OF
MERCER, STATE OF NEW JERSEY, AUTHORIZING CHANGE ORDER #3, TIME
EXTENSION, AND FINAL QUANTITIES TO THE CONTRACT FOR BID #23-06
SANITARY SEWER SYSTEM REHABILITATION**

WHEREAS, the Township of Hopewell awarded Bid #23-06 to National Water Main Cleaning Company, through Resolution 23-226 on June 12, 2023, in the aggregate amount of \$833,357.93; and

WHEREAS, the Township of Hopewell approved Change Order No. 1 through Resolution 24-90 on March 4, 2024, in the amount of \$3,725.00; and

WHEREAS, the Township of Hopewell approved Change Order No. 2 through Resolution 24-164 on April 24, 2024, in the amount of \$24,420.00; and

WHEREAS, there is a need for additional work under Pay Items #13 and #14 and a reduction in other pay items based on final as-built quantities within the contract; and

WHEREAS, the New Jersey Department of Environmental Protection has requested an additional 103 days to the time of completion for Bid #23-06 in order complete all necessary financial and administrative tasks for a revised completion date of August 1, 2024; and

WHEREAS, pursuant to the design engineer's recommendation, it is recommended that this change order be allowed; and

WHEREAS, in accordance with N.J.A.C. 5:30-11.3, all of the change orders have not caused the originally awarded contract price to be exceeded by more than 20 percent; and

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Hopewell, in the County of Mercer and State of New Jersey, that it authorizes a written amendment in the form of Change Order #3 for a net increase of \$3,624.44 for a final total contract price in the amount of \$865,127.37 and an increase of 103 days to the time of completion for a revised completion date of August 1, 2024 to National Water Main Cleaning Co. for bid #23-06 Sanitary Sewer System Rehabilitation and to the time of in accordance with N.J.A.C. 5:30-11.1 et. Seq.
