**RESOLUTION AUTHORIZING AWARD OF CONTRACT TO  
CENTURY LINK COMMUNICATIONS dba/LUMEN TECHNOLOGIES THROUGH  
HOUSTON GALVESTON AREA COOPERATIVE (HGAC) NATIONAL  
COOPERATIVE CONTRACT EC07-23 FOR 9-1-1 EQUIPMENT & EMERGENCY  
NOTIFICATION SOFTWARE AND SERVICES**

**WHEREAS**, in accordance with the requirements of the Local Public Contract Law P.L. 2011, C.139 (the "Law" or "Chapter 139" and N.J.S.A.52:34-6.2 the regulations promulgated there under in Local Finance Notice LFN 2012-10, the following purchase without competitive bids from vendor with a National Cooperative Contract is hereby approved for municipalities; and

**WHEREAS**, the Township of Hopewell has the need to procure certain specialized 9-1-1 Equipment & Emergency Notification Software & Services, for the total Sum of \$208,600.00 in accord with the Local Publics Contract Law N.J.S.A. 40A:11-1 et. Seq.; and

**WHEREAS**, the Township of Hopewell has previously acted in accord with New Jersey public procurement statutes and regulations as promulgated by formally joining a recognized and compliant national cooperative, being the HGAC National Cooperative; and

**WHEREAS** the regulations as set forth within Local Finance Notice LFN 2012-10 have been fully complied with; and

**WHEREAS**, the Qualified Purchasing Agent has complied with the public notification provisions of public advertisement and has received no protests in accord with law and regulation; and

**WHEREAS** the equipment and corresponding HGAC National Cooperative contract number is: #EC07-23 for Century Link Communications dba/ Lumen Technologies; and

**WHEREAS**, the Township is desirous of purchasing 9-1-1 Equipment & Emergency Notification Software & Services through Century Link Communications dba/ Lumen Technologies, and accessories, through HGAC contract: #EC07-23 including accessories and an amount not to exceed \$208,600.00; and

**WHEREAS** the Chief Financial Officer certifies the funding is available in the amount of \$208,600.00
