**RESOLUTION #24-325**

**RESOLUTION REQUESTING THE COUNTY OF MERCER TO ESTABLISH  
SPEED LIMITS ON PENNINGTON-HARBOURTON ROAD (CR 623) WITHIN  
HOPEWELL TOWNSHIP, MERCER COUNTY**

**WHEREAS**, the Township Committee of the Township of Hopewell desires to improve traffic safety by setting appropriate speed limits on Pennington-Harbourton Road (CR 623) within Hopewell Township, Mercer County; and

**WHEREAS**, the speed limit for both directions of traffic along Pennington-Harbourton Road (CR 623) between N.J. Route 31 to a point 900 feet west of the intersection of Pennington-Harbourton Road (CR 623) with the centerline of Hallett Drive in Hopewell Township, Mercer County should be established as follows:

Zone 1: 35 MPH between N.J. Route 31 and a point 900 feet west of the intersection of Pennington-Harbourton Road (CR 623) with the centerline of Hallett Drive and;

**WHEREAS**, the County of Mercer requires a resolution of support from affected municipalities in order to adopt such resolution; and

**WHEREAS**, the Township Committee of the Township of Hopewell, as well as Township residents, have expressed concern regarding motorist safety at the intersection of Pennington-Harbourton Road (CR623) and Scotch Road; and

**WHEREAS**, there have been 10 motor vehicle crashes at the Pennington-Harbourton Road (CR623) and Scotch Road intersection since 2019, including six injuries and one fatality; and

**WHEREAS**, on February 20, 2024 the Township Committee of the Township of Hopewell adopted Resolution #24-70 requesting that the County of Mercer cooperatively investigate potential traffic safety improvements at the intersections of Pennington-Harbourton Road (CR623) and Scotch Road and Pennington-Titusville Road and Scotch Road.


**NOW, THEREFORE BE IT RESOLVED**, the Township Committee of the Township of Hopewell, County of Mercer, State of New Jersey, that:

1. The Township Committee hereby supports a Mercer County resolution establishing speed limits along Pennington-Harbourton Road (CR 623), Hopewell Township, Mercer County.
2. The Township Committee hereby requests the County of Mercer to conduct the necessary studies and warrant analyses to consider an all-way stop at the intersection of Pennington-Harbourton Road (CR 623) and Scotch Road.
3. The Municipal Clerk is directed to forward a copy of this resolution to the Mercer County Commissioners.
