WHEREAS, the Township of Hopewell, Mercer County, State of New Jersey, desires to apply for and obtain a grant from the New Jersey Department of Community Affairs for approximately \$500,000 to carry out a project for Senior and Community Center Improvements

THEREFORE, BE IT RESOLVED:

- 1) that the Township Committee of the Township of Hopewell does hereby authorize the application for such a grant; and,
- 2) recognizes and accepts that the Department may offer a lesser or greater amount and therefore, upon receipt of the grant agreement from the New Jersey Department of Community Affairs, does further authorize the execution of any such grant agreement; and also, upon receipt of the fully executed agreement from the Department, does further authorize the expenditure of funds pursuant to the terms of the agreement between the Township of Hopewell, Mercer County, and the New Jersey Department of Community Affairs.
