**R E S O L U T I O N #24-362**

**A RESOLUTION AUTHORIZING REFUND OF PAID TAX DUE TO VETERAN  
EXEMPTION GRANTED ON BLOCK 46.07 LOT 1 AND CANCELLATION OF 2024-  
2025 TAXES**

**WHEREAS**, Block 46.07 Lot 1, known as 197 Penn View Drive, is assessed to Moody Wayne R & Lee B; and

**WHEREAS**, Mr. Moody had applied for, and had been granted as of October 8, 2024 by the Assessor of the Township of Hopewell, the status of totally disabled veteran, and, as a totally disabled veteran, Mr. Moody is exempt from paying New Jersey real estate taxes; and

**WHEREAS**, the effective date of eligibility as set by the United States Department of Veteran Affairs for Mr. Moody was October 24, 2022; the date of request to the Township was October 8, 2024; and

**WHEREAS**, on August 23, 2010 the Township of Hopewell, Mercer County, did pass Resolution #10-224, establishing the policy and effective date of disability for exempt veterans to be “the date of disability as declared by the United States Department of Veterans Administration, not exceeding one year prior to the date of the request;” this Resolution was reaffirmed December 28, 2018 for a period of 7 years (18-363); and

**WHEREAS**, Mr. Moody’s exemption status is dated to October 8, 2023, one year prior to the date of application; and

**WHEREAS**, the Moodys paid \$20,258.34 in tax for the period of October 8, 2023 to September 30, 2024; this amount should be refunded; and

**WHEREAS**, as an exempt veteran Mr. Moody’s taxes for the fourth quarter 2024 and the first half 2025 should be cancelled; and


**NOW, THEREFORE BE IT RESOLVED**, on this 12th day November 2024 by the Township Committee of the Township of Hopewell, County of Mercer, State of New Jersey, that these taxes on Block 46.07 Lot 1 be cancelled, and the Moodys refunded \$20,258.34.

**BE IT FURTHER RESOLVED** that a copy of this resolution shall be forwarded to the Tax Collector, Tax Assessor, and Finance Officer.
