**A RESOLUTION OF THE TOWNSHIP OF HOPEWELL, IN THE  
COUNTY OF MERCER, STATE OF NEW JERSEY, SUPPORTING  
AN ORDINANCE BY THE COUNTY OF MERCER ESTABLISHING  
SPEED LIMITS ALONG COUNTY ROUTE 623 (PENNINGTON-  
HARBOURTON ROAD), HOPEWELL TOWNSHIP, MERCER  
COUNTY**

**WHEREAS**, the Township Committee of the Township of Hopewell, as well as Township residents, have expressed concern regarding traffic safety at the intersections of County Route 623 (Pennington-Harbourton Road between County Route 579 (Trenton-Harbourton) and NJ Route 31, Hopewell Township, Mercer County; and

**WHEREAS**, the intention of the Board of County Commissioners of the County of Mercer, State of New Jersey, is to create and adopt an Ordinance addressing such concerns by establishing the following:

1. The speed limits for both directions of traffic along County Route 623 (Pennington-Harbourton Road) BETWEEN County Route 579 (Trenton-Harbourton) AND NJ Route 31, Hopewell Township, Mercer County, are to be established as follows:

Zone 1: 35 MPH from Trenton-Harbourton Road (County Route 579) to the Hopewell Township-Pennington Borough Corporate Line; thence

2. This Ordinance shall take effect upon approval by the Board of County Commissioners; and
3. Regulatory and Warning signs shall be erected and maintained to affect the above designated speed limits in accordance with the Manual on Uniform Traffic Control Devices; and

**WHEREAS**, the Hopewell Township Committee believes that the above traffic improvements are of utmost importance to the safety and well being of those traveling the roads of Hopewell Township.

**NOW THEREFORE BE IT RESOLVED**, that the governing body of the Township of Hopewell hereby enthusiastically support the adoption of an Ordinance establishing speed limits along County Route 623 (Pennington-Harbourton Road), Hopewell Township, Mercer County, by the Mercer County Board of Commissioners.

**BE IT FURTHER RESOLVED**, by the Township Committee of the Township of Hopewell that a copy of this resolution be forwarded to the Mercer County Commissioners.
