R E S O L U T I O N #24-389

A RESOLUTION OF THE TOWNSHIP OF HOPEWELL, IN THE COUNTY OF MERCER, STATE OF NEW JERSEY, SUPPORTING AN ORDINANCE BY THE COUNTY OF MERCER ESTABLISHING A 4-WAY STOP INTERSECTION PURSUANT TO THE PROVISIONS OF N.J.S.A. 39:4-140, AT THE INTERSECTION OF PENNINGTON-HARBOURTON ROAD (COUNTY ROUTE 623), SCOTCH ROAD, AND BURD ROAD IN THE TOWNSHIP OF HOPEWELL, COUNTY OF MERCER.

WHEREAS, the Township Committee of the Township of Hopewell, as well as Township residents, have expressed concern regarding traffic safety at the intersections of County Route 623 (Pennington-Harbourton Road), Scotch Road, and Burd Road, Hopewell Township, Mercer County; and

WHEREAS, the intention of the Board of County Commissioners of the County of Mercer, State of New Jersey, is to create and adopt an Ordinance addressing such concerns by establishing the following:

1. The purpose of this Ordinance is to establish a 4-way stop control on roadways that are open to the public as set forth below.
2. Pursuant to the provisions of N.J.S.A. 39:4-140, the intersection herein described is designated as a 4-way stop intersection. Stop signs shall be installed as provided herein.

Intersection Stop Signs

Pennington-Harbourton Road (County Route 623)/ All Approaches
Scotch Road/ Burd Road Township of Hopewell, County of Mercer, State of New Jersey; and

3. Regulatory and Warning signs shall be erected and maintained to affect the above designated speed limits in accordance with the Manual on Uniform Traffic Control Devices; and

WHEREAS, the Hopewell Township Committee believes that the above traffic improvements are of utmost importance to the safety and well being of those traveling the roads of Hopewell Township.

NOW THEREFORE BE IT RESOLVED, that the governing body of the Township of Hopewell hereby enthusiastically support the adoption of an Ordinance establishing a 4-way stop intersection pursuant to the provisions of N.J.S.A. 39:4-140, at the intersection of Pennington-Harbourton Road (County Route 623), Scotch Road, and Burd Road in the Township of Hopewell, County of Mercer.

BE IT FURTHER RESOLVED, by the Township Committee of the Township of Hopewell that a copy of this resolution be forwarded to the Mercer County Commissioners.
