In such case(s), within one business day of the decision to conduct the meeting via Zoom®, the Township will post the Municipal Complex Main Entrance and Official Bulletin Board in the Municipal Building, publish notice on the Township website and Facebook® and other social media platforms and provide an electronic copy of said notice to all persons who request a copy; and

**BE IT FURTHER RESOLVED** that copies of this Resolution be posted and maintained posted throughout the year in accordance with the statutes; and

**BE IT FURTHER RESOLVED** that copies of this Resolution and schedule be forwarded to the official newspapers of the Township.
