**A RESOLUTION PERMITTING A FIREWORKS DISPLAY BY THE  
HOPEWELL VALLEY VETERAN'S ASSOCIATION – JUNE 28, 2025**

**WHEREAS**, The Hopewell Valley Veteran's Association (HVVA) has made application for permission to hold a fireworks display on Saturday, June 28, 2025 in conjunction with the band concert to be conducted at Woolsey Park, Washington Crossing-Pennington Road, Titusville, NJ at 9:00 p.m. with a rain date of Sunday, June 29, 2025; and

**WHEREAS**, the Uniform Fire Code (NJAC 5:70 et seq.) and the New Jersey Fireworks Act (NJSAA 21:2-1 et. seq.) provides that the Governing Body of the Municipality may, upon application in writing, grant permission for a public display of fireworks by organizations or groups of individuals;

**NOW, THEREFORE, BE IT RESOLVED** that the Township Committee of the Township of Hopewell, County of Mercer and State of New Jersey does hereby grant permission to the HVVA to hold a fireworks display Saturday, June 28, 2025 in conjunction with a band concert to be conducted at Woolsey Park, Washington Crossing-Pennington Road, Titusville, NJ at 9:00 p.m. with a rain date of Sunday, June 29, 2025; subject to the following conditions:

- (1) Submission to the Township Fire Official, Andrew J. Fosina, Jr., an application pursuant to and meeting the specifications of the Uniform Fire Code and the New Jersey Fireworks Act;
- (2) Approval of the location of the storage place for said fireworks by the Township Fire Official, Andrew J. Fosina, Jr.;
- (3) Submission of Certificate of Insurance by the Vendor covering the fireworks; and
- (4) Submission of Surety as per N.J.S.A. 21:3-5.

The party of the first part agrees to inspect the area the night of the display to safely remove and dispose of any unexploded shells or live components. Furthermore, the party of the second part agrees to take responsibility for the cleanup of fallout debris after the display. The party of the second part agrees to procure any and all necessary permits and licenses, which may be required by the municipal or state authorities. International Fireworks Mfg Co will do a post display inspection the night of the display any first light inspection is the responsibility of the sponsor**

In the event of total cancellation before set up, the party of the second part agrees to pay 50% of the contract price plus expenses incurred. It is also understood and agreed by the parties hereto that in the event the fireworks have been taken out and set up before any rain then such exhibition of fireworks must be carried out in the best possible manner without any deductions whatever from the hereinafter named compensation.**

**The party of the second part agrees to pay the total contract price of \$10,200. to International Fireworks Mfg. Co. within 10 days after this display has been performed.**


