**A RESOLUTION OF THE TOWNSHIP OF HOPEWELL, IN THE COUNTY OF
MERCER, STATE OF NEW JERSEY, AMENDING RESOLUTION #25-30
AUTHORIZING TOWNSHIP OF HOPEWELL CHANGE ORDER #1 TO THE
CONTRACT FOR BID FOR PENNINGTON ROCKY HILL ROAD
IMPROVEMENTS THROUGH EARLE ASPHALT COMPANY**

WHEREAS, the Township of Hopewell awarded bid #23-12 to Earle Asphalt Company through, in the aggregate amount of \$498,713.13; and

WHEREAS, at its January 13, 2025 regular Township Committee Meeting the governing body adopted Resolution #25-30 authorizing Change Order #1 to the contract for bid for Pennington Rocky Hill Road Improvements through Earle Asphalt Company which contained erroneous data; and

WHEREAS, the resolution shall be amended as follows;

WHEREAS, the design engineers have concluded unforeseen paving and road improvement matters were required, unforeseen in the original bid for service; and

WHEREAS the amount of change order requested is a net decrease of \$18,798.14, which represents in the aggregate, a decrease in the overall price less than the statutory increase limit of 20% change order as a minor modification; and

WHEREAS, pursuant to attached per the design engineer memo, it is recommended that this change order be allowed; and

WHEREAS, in accordance with N.J.A.C. 5:30-11.3, the change order has not caused the originally awarded contract price to be exceeded by more than 20 percent.


NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Hopewell, in the County of Mercer and State of New Jersey, that it authorizes a written amendment in the form of Change Order #1 a decrease in the amount of \$18,798.14 for a total contract price of \$479,914.99 to Earle Asphalt Company stemming from bid #23-12, Pennington Rocky Hill Road, in accord with N.J.A.C. 5:30-11.1 et. Seq.,

BE IT FURTHER RESOLVED that the above amendments to this resolution will take effect immediately upon its passage.
