**RESOLUTION APPROVING THE APPLICATION OF
THE SUDC FOUNDATION TO CONDUCT MILES FOR MALCOLM 5K**

WHEREAS, application has been made by the SUDC Foundation to conduct a Memorial 5K run in the Township of Hopewell at Pennington Montessori School on April 26, 2025; and

WHEREAS, the Hopewell Township Health Officer, the Hopewell Township Police Department and the Hopewell Township Bureau of Fire Safety have reviewed the application and granted their approval to conduct the festival and recommend the granting of a permit pursuant to the Revised General Ordinances of the Township of Hopewell, Chapter IV, Section 4-3 Festivals and Large Assemblies.

NOW, THEREFORE, BE IT RESOLVED that:

1. This Resolution shall constitute a permit to conduct a Memorial 5K Run in accordance with the application submitted by The SUDC Foundation, which festival is to be held on April 26, 2025 at Pennington Montessori School in Hopewell Township.
2. The SUDC Foundation shall be exempted from the several provisions of 4-3, et seq. (4-3.8 Exemptions. a. Charitable or non-profit organizations) except those provided by 4-3.4, Insurance Requirement.
3. The Municipal Clerk is directed to forward a certified copy of this resolution to The SUDC Foundation, 101 Eisenhower Parkway, Suite 300, Roseland, NJ 07068.

Miles For Malcolm, April 26, 2025

Event Description:

The SUDC Foundation to host the “Miles for Malcolm” Run Event at Pennington Montessori in Hopewell, NJ in remembrance of Malcolm Wildszewski. Malcolm attended the Pennington Montessori school and passed away in 2020, at the age of 2 years. Proceeds to benefit the SUDC Foundation (sudc.org). There will be food, kids face painting, balloon animal crafts, and refreshments along with a 5K and 5-Mile run.

- The Pennington Montessori school parking lot will be blocked off for race with volunteers and race participants entering only.
- Porta johns and bottled water will be provided by the organizer.
- All food and beverage items will be distributed rather than grabbed out of a communal bin or cooler. Food will be pre-wrapped or need to be peeled (bananas and/or oranges).
- A professional timing company will be hired to create official start and finish lines to maintain crowd control and safety.
- There will also be volunteers to help with crowd control reminding everyone in attendance to behave responsibly via loudspeaker/microphone.
- CDC guidelines as well as local and executive orders at the time of the event will be adhered too.
- Hopewell Emergency Medical Unit will be contracted to be onsite during the event.
- Hopewell Police (4 officers) will be hired to maintain traffic flow and road safety for the duration of the race, about 1 ½ hours.
- With the exception of the race, the entire event will be held on the grounds of the Pennington Montessori school.


