**RESOLUTION AWARDING CC# 25-02 GRANTS WRITING SERVICES TO THE
AUBREY GROUP LLC IN A FAIR AND OPEN MANNER**

WHEREAS, there is a need for grants writing services for the daily operations of the Township of Hopewell; and

WHEREAS, the New Jersey Local Public Contracts Law (N.J.S.A. 40A:11-4.1 et seq.) allows the use of competitive contracts and approved by council resolution; and

WHEREAS, the Township duly advertised for public receipt of competitive contracts providing the required 20 days prior to receipt for CC#25-02 in a fair and open manner, consistent with N.J.S.A.19:44A-20.5 et. Seq; and

WHEREAS, the Township received competitive contracts for grants writing services on February 26, 2025, at 11:00 A.M; and

WHEREAS, the rating committee has reviewed the submittals and rated according to the directions under competitive contracts, as required within N.J.A.C. 5:34-4 et seq., and

WHEREAS, The Aubrey Group LLC, 121 Market Street, Camden, New Jersey, 08102, has provided the response most advantageous to the Township, under the demands of price and other factors found within statute; and

WHEREAS, the process was administered as required by law by the Qualified Purchasing Agent who has concurred with the legality of the purchase in accord with the New Jersey Local Publics Contract Law (N.J.S.A. 40A:11-1 et seq.); and

WHEREAS, the term of contract is allowable for up to five (5) years as authorized under N.J.S.A.40A:11-4.1 et seq.; and

WHEREAS, The Aubrey Group LLC, 121 Market Street, Camden, New Jersey, 08102, has proposed a fee structure of:
