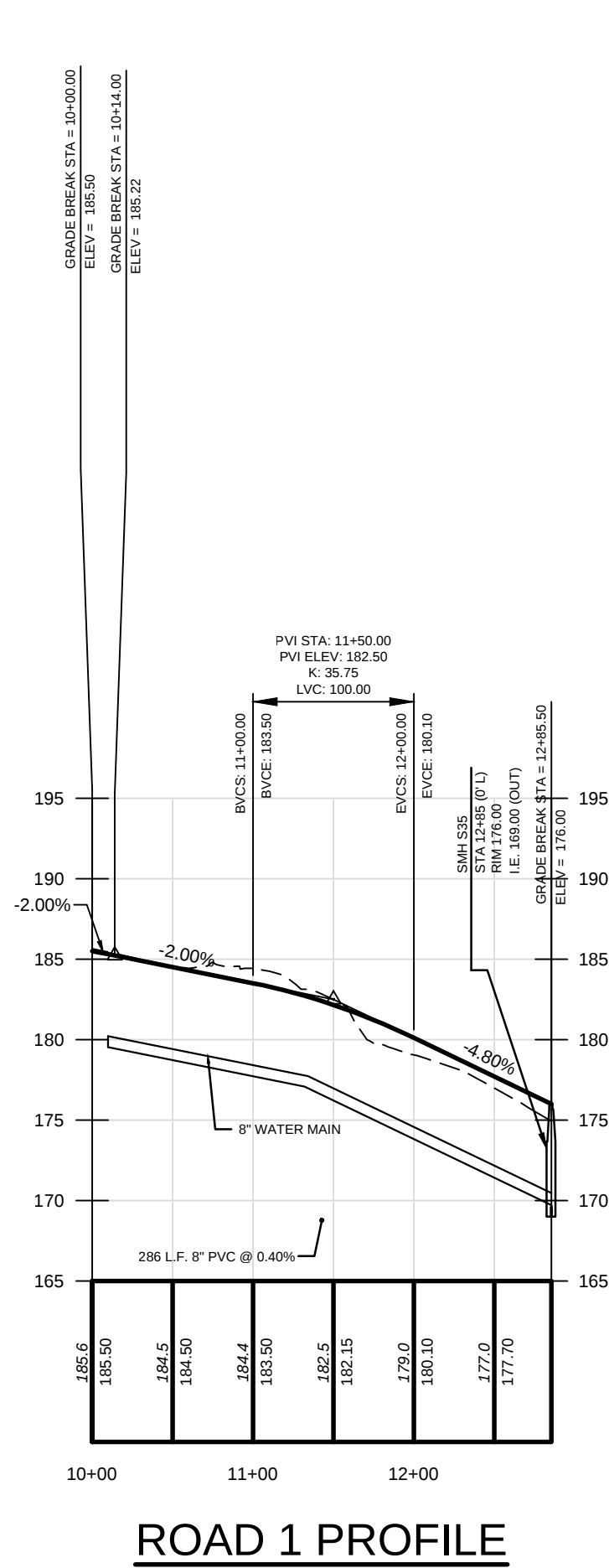
ROAD 3 PROFILE



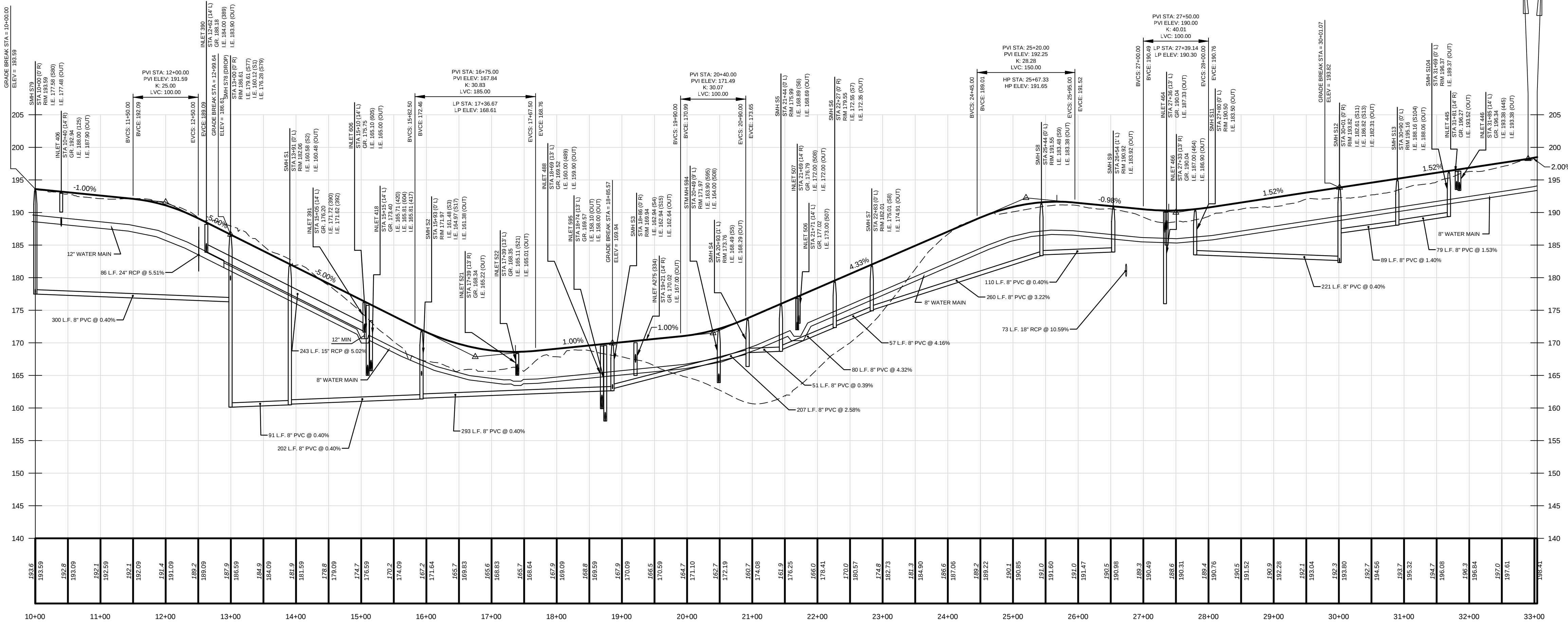

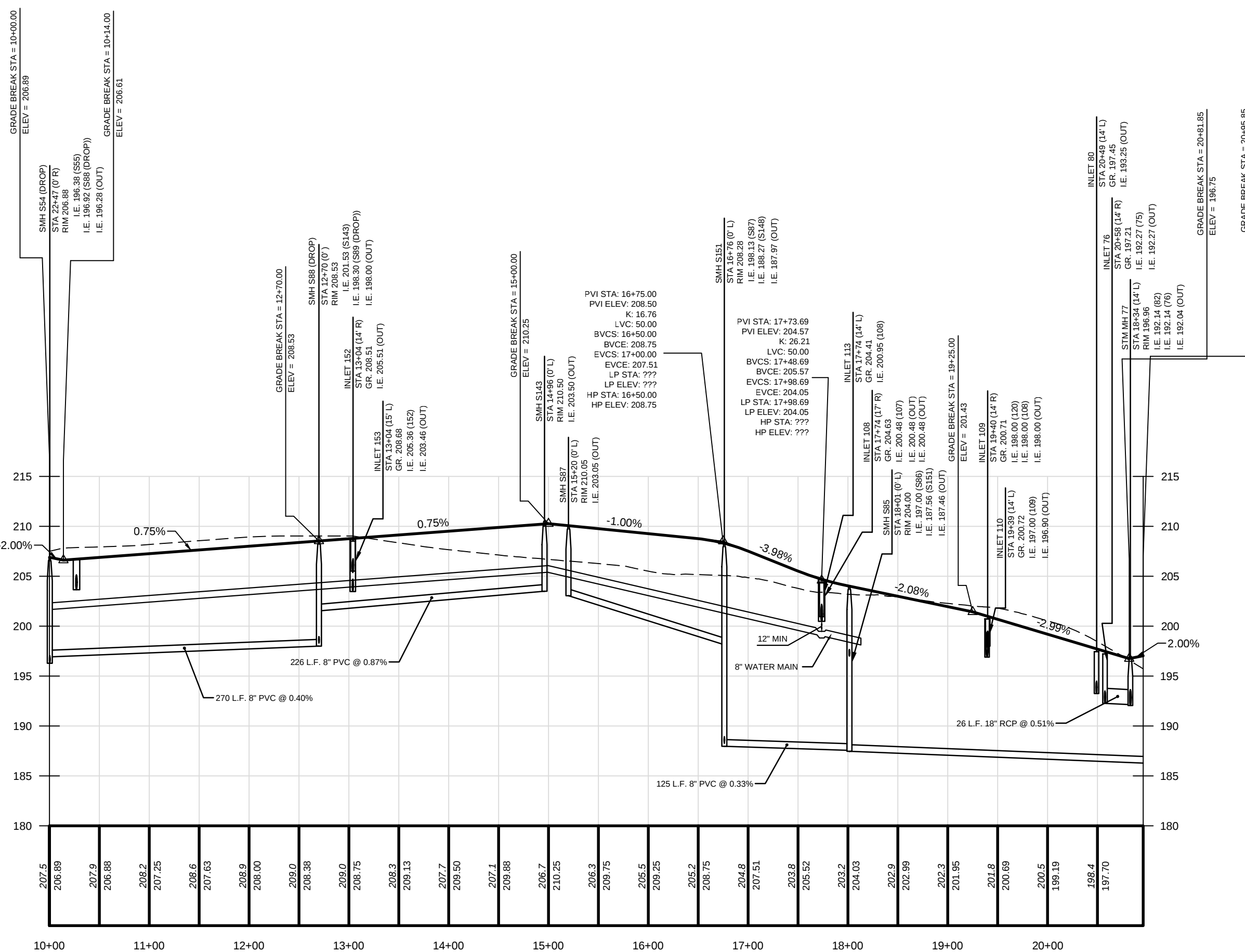
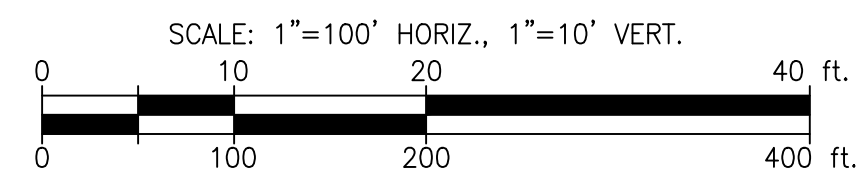
ROAD 6 PROFILE



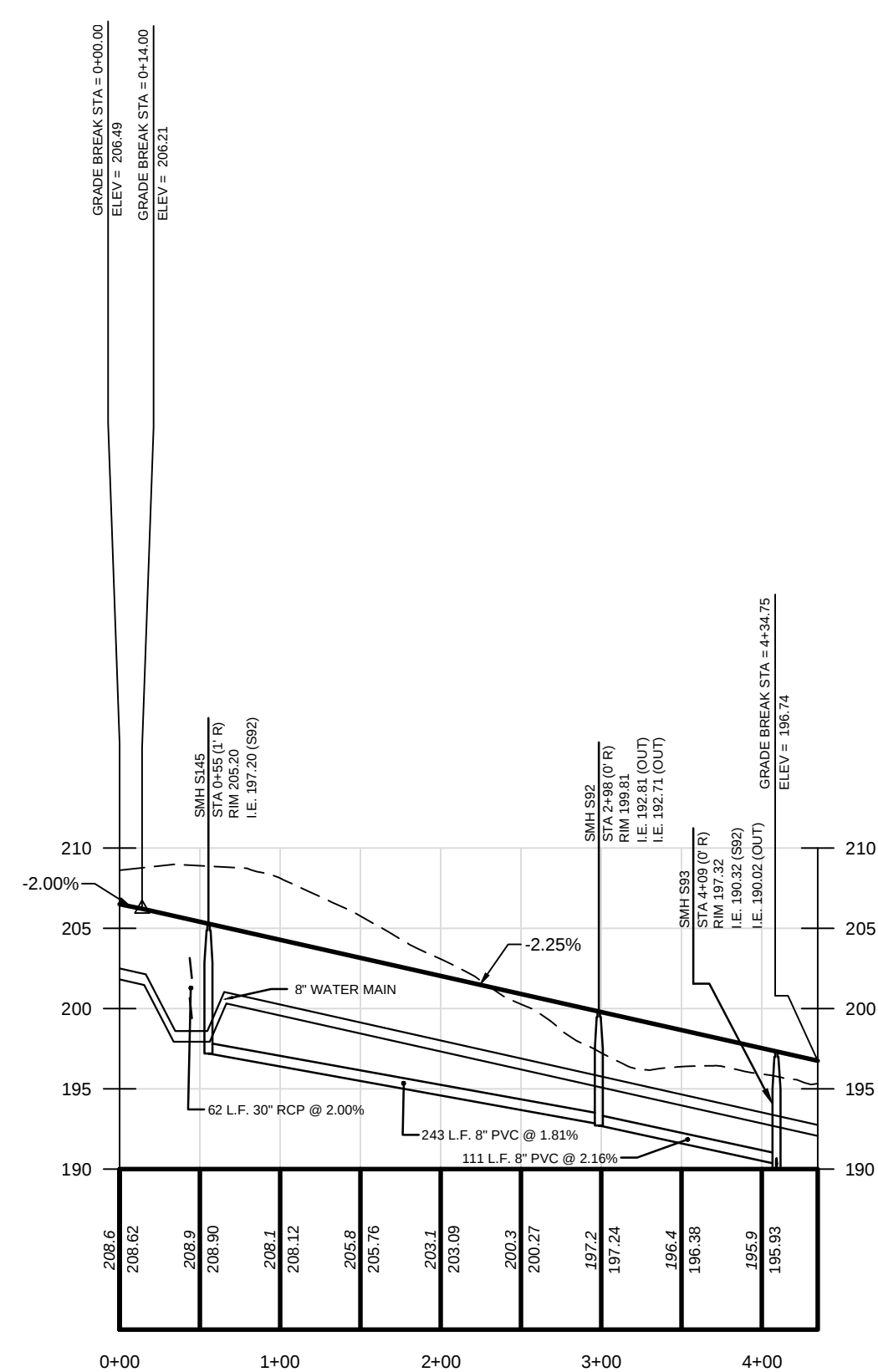
