**A RESOLUTION AUTHORIZING THE EXECUTION OF THE AGREEMENT WITH  
EWING TOWNSHIP AND LAWRENCE TOWNSHIP FOR THE DEVELOPMENT  
OF A GRANT APPLICATION FOR THE NEW JERSEY DEPARTMENT OF  
TRANSPORTATION'S LOCATION TRANSPORTATION PROJECT FUND**

**WHEREAS**, the Township of Hopewell ("Hopewell") is charged with promoting the safety and wellbeing of residents; and

**WHEREAS**, there has been an increase in automobile traffic along federal city road, particularly at the intersections of Federal City Road and Bull Run Road and Federal City and Federal Point; and

**WHEREAS**, the above-mentioned intersections affect not only Hopewell but Ewing Township ("Ewing") and Lawrence Township ("Lawrence") as well; and

**WHEREAS**, Hopewell, Ewing, and Lawrence, wish to explore traffic calming measures and desire to submit a grant application to the New Jersey Department of Transportation's Local Transportation Project Fund ("LTPF"); and

**WHEREAS**, the Parties wish to enter into a Memorandum of Understanding ("MOU") to memorialize the basic terms under which the Parties will work collaboratively for the purpose of drafting and submitting the LTPF grant application by June 30, 2025; and

**WHEREAS**, the Township Committee consents to the entering of this agreement; and

**NOW THEREFORE, BE IT RESOLVED**, by the Township Committee of the Township of Hopewell, County of Mercer, State of New Jersey that:

The Township is authorized to enter into a Memorandum of Understanding with the Townships of Ewing and Lawrence of County of Mercer, New Jersey for the drafting and submission of a grant application to the Department of Transportation's Local Transportation Project Fund. The cost of the project as outlined in this agreement shall not exceed \$5,000.00.

The Mayor is authorized to execute all necessary documents to effectuate this agreement.
