Baseball Camp	- Range is from 4-5 hours per day
Teen Travel	- Range is from 7-9 hours per day
Junior Travel	- Range is from 3.5-4.5 hours per day
Soccer Camp	- Range is from 3.5-4.5 hours per day
Field Hockey Clinic	- Range is from 2-3 hours per day
Speed & Agility Camp	- Range is from 2.5-3.5 hours per day
Track & Field Clinic	- Range is from 2.5-3.5 hours per day
