**RESOLUTION APPROVING THE APPLICATION OF  
COMMUNITY 4TH OF JULY TITUSVILLE  
TO CONDUCT A 4TH OF JULY PARADE/FESTIVAL**

**WHEREAS**, application has been made by Community 4<sup>th</sup> of July Titusville to conduct a 4<sup>th</sup> of July Parade/Festival in the Township of Hopewell in Titusville, New Jersey on River Drive from Grant Street to Church Road on July 4, 2025, between the hours of 10:00 a.m. and 2:00 p.m.; and

**WHEREAS**, the Hopewell Township Health Officer, the Hopewell Township Police Department and Hopewell Township Bureau of Fire Safety are in the process of reviewing the application and granting their approval to conduct the parade pursuant to the Revised General Ordinances of the Township of Hopewell, Chapter IV, Section 4-3 Festivals and Large Assemblies.

**NOW, THEREFORE, BE IT RESOLVED that:**

1. Issuance of this permit shall be pending approval from the Hopewell Township Health Officer, the Hopewell Township Police Department and the Hopewell Township Bureau of Fire Safety.
2. This Resolution shall constitute a permit to conduct a 4<sup>th</sup> of July Parade in accordance with the application submitted by Community 4<sup>th</sup> of July Titusville, which is to be held July 4, 2025, on River Drive from Grant Street to Church Road in Hopewell Township.
3. Community 4<sup>th</sup> of July Titusville shall be exempted from the several provisions of 4-3, et seq. (4-3.8 Exemptions. a. Charitable or non-profit organizations) except those provided by 4-3.4, Insurance Requirement.
4. All Mobile Food Truck Facilities shall be licensed by the Municipal Clerk and receive their permits from the Health Department and Fire Bureau no later than two (2) weeks prior to the event.
5. The Municipal Clerk is directed to forward a certified copy of this resolution to Community 4<sup>th</sup> of July Titusville, 100 River Drive, Titusville, NJ 08560.
