**A RESOLUTION OF THE HOPEWELL TOWNSHIP COMMITTEE EXPRESSING
SUPPORT FOR THE HOPEWELL BOROUGH TRAFFIC CALMING MEASURES ON
NORTH GREENWOOD AND WASHINGTON STREETS, INCLUDING THE EXTENSION
OF DOUBLE YELLOW LINES INTO TOWNSHIP BORDERS**

WHEREAS, Hopewell Borough has developed a traffic calming plan for North Greenwood and Washington Avenues to address ongoing safety concerns in the area; and

WHEREAS, the proposed traffic calming measures include, amongst other changes, extension of double yellow lines from the Borough into Township borders for approximately 40 feet onto Hopewell-Wertsville Road, to create consistent and clear traffic patterns for motorists; and

WHEREAS, the Township recognizes the importance of regional coordination in traffic safety initiatives, particularly where roadways cross municipal boundaries; and

WHEREAS, the safety and well-being of residents, including children, elderly persons, and families who live, work, and travel along these corridors, is of paramount concern to both municipalities; and

WHEREAS, the extension of double yellow lines into Township territory represents a minimal but effective traffic calming measure that will enhance safety by creating clear expectations for drivers; and

WHEREAS, the Township values its collaborative relationship with the Borough and recognizes that traffic safety transcends municipal boundaries, requiring coordinated efforts to protect all residents of both communities; and

WHEREAS, the proposed traffic calming measures align with the Township's commitment to promoting safe streets and protecting vulnerable road users throughout the community.


NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Hopewell, County of Mercer, State of New Jersey that:

1. The Township hereby expresses its support for the Borough's traffic calming plan for North Greenwood and Washington Streets.
2. The Township specifically endorses the extension of double yellow lines from the Borough into Township borders as an appropriate and necessary safety measure.
3. The Township authorizes appropriate municipal officials to work with Borough officials to facilitate the implementation of these safety improvements, if necessary.
4. The Borough shall bear the cost of the installation and maintenance of the extension of double yellow lines from the Borough into Township borders for approximately 40 feet onto Hopewell-Wertsville Road.
5. This Resolution shall take effect immediately upon adoption.
