**RESOLUTION AUTHORIZING AMENDMENT TO AWARD OF CONTRACT TO EAGLE  
POWER KUBOTA THROUGH SOURCEWELL NATIONAL COOPERATIVE CONTRACT  
082923-KBA FOR ONE KUBOTA TRACTOR MODEL M5-111HDC12-1**

**WHEREAS**, in accordance with the requirements of the Local Public Contract Law P.L. 2011, C.139 (the "Law" or "Chapter 139" and N.J.S.A.52:34-6.2 the regulations promulgated thereunder in Local Finance Notice LFN 2012-10, the following purchase without competitive bids from vendor with a National Cooperative Contract is hereby approved for municipalities; and

**WHEREAS**, the Township of Hopewell has the need to procure certain specialized public works tractor equipment in accord with the Local Public Contracts Law N.J.S.A. 40A:11-1 et. Seq.; and

**WHEREAS**, the Township of Hopewell has previously acted in accord with New Jersey public procurement statutes and regulations as promulgated by formally joining a recognized and compliant national cooperative, being the Sourcewell National Cooperative through Resolution 15-290 on September 4, 2015; and

**WHEREAS**, the regulations as set forth within Local Finance Notice LFN 2012-10 have been fully complied with; and

**WHEREAS**, the Qualified Purchasing Agent has complied with the public notification provisions of public advertisement and has received no protests in accord with law and regulation; and

**WHEREAS**, the equipment and corresponding Sourcewell National Cooperative contract number is: 082923-KBA for Eagle Power Kubota, 63 Route 31 North, Pennington, NJ 08534; and

**WHEREAS**, Resolution #25-283, adopted on July 14, 2025, authorized the purchase of one (1) Kubota Tractor - M5-111HDC12-1, through Sourcewell contract: 081716-KTC, in the amount of \$65,491.43; and

**WHEREAS**, an upcharge of \$3,068.52 is necessary for the final configuration of the Kubota Tractor, bringing the total purchase amount to \$68,559.95, which remains below the originally projected cost of \$70,000.00; and


**WHEREAS**, the Chief Financial Officer certifies that adequate funding is available in the amount of \$68,559.95 from budget account X-12-00925-230.

**NOW, THEREFORE, BE IT RESOLVED**, on this 14th day of July 2025 by the Township Committee of the Township of Hopewell, County of Mercer, State of New Jersey, that the Department of Public Works be and hereby is authorized to procure one (1) Kubota Tractor - M5-111HDC12-1, through Sourcewell contract: 081716-KTC, in the amended amount of **\$68,559.95**, from Eagle Power Kubota, 63 Route 31 North, Pennington, NJ 08534.
