**RESOLUTION TO AWARD AMBULANCE BID TO EMERGENCY EQUIPMENT  
SALES LLC FOR BIDS 24-14/ 24R-14**

**WHEREAS**, the terms of the negotiated agreement are consistent with the Memorandum of Understanding (MOU) between Mercer County and the Township of Hopewell on August 20, 2024, which outlines the scope, responsibilities, and applicable ARPA terms and conditions.

**WHEREAS** the Township of Hopewell has a need for an ambulance compliant with the specifications as put forth in bids 24-14 and 24R-14; and

**WHEREAS**, the Township had sought obtaining a vendor through two (2) bids, 24-17/ 24R-17 on March 12, 2025, and April 9, 2025, where no bids were received; and

**WHEREAS** the Township availed itself of the negotiations remedy under the New Jersey Local Publics Contract Law at N.J.S.A.40A:11-5(3); and

**WHEREAS**, the Township representatives engaged in negotiations with the Emergency Equipment Sales LLC, 119 Winterwood Ave., Ewing, N.J. 08638, in accordance with N.J.S.A. 40A:11-5(3) for the terms and tenets as contained within bids 24-17/24R-17; and

**WHEREAS** Emergency Equipment Sales LLC has proposed providing one (1) 2025 Ford T-350 AWD Type II Transit Ambulance and accessories, consistent with vehicles sought in bids 24-14/24R-14, acceptable to the Township, and consistent with bid specifications, in the amount of \$228,780.60; and

**WHEREAS** the Chief Financial Officer certifies funding is available in the amount of \$228,780.60 from Line Item: X-02-00-920-012; and

**WHEREAS**, the Chief Financial Officer certifies that funding is available in the amount of \$228,780.60 from Line Item: X-02-00-920-012, which is supported by federal funds received under the American Rescue Plan Act (ARPA);

**NOW, THEREFORE, BE IT RESOLVED** by the Township Committee of the Township of Hopewell, in the County of Mercer as follows:

Emergency Equipment Sales LLC is hereby awarded the bid for providing one (1) 2025 Ford T-350 AWD Type II Transit Ambulance and accessories. consistent with vehicles sought in bids 24-14/24R-14, acceptable to the Township and consistent with bid specifications, in the amount of \$228,780.60, in accordance with N.J.S.A. 40A:11-5(3). This purchase shall be funded using American Rescue Plan Act (ARPA) funds.
