R E S O L U T I O N 25-401

**RESOLUTION AUTHORIZING AN AGREEMENT WITH THE STATE OF NEW JERSEY
FOR A DEER MANAGEMENT PROGRAM GRANT**

WHEREAS, the Township of Hopewell recognizes the importance of effective deer management for public safety, environmental health, and the well-being of its residents; and

WHEREAS, the State of New Jersey is offering grant funds to municipalities to support local Deer Management Programs; and

WHEREAS, the Township of Hopewell has been approved to receive a grant in the amount of Eight Thousand Two Hundred Fifty Dollars (\$8,250.00) from the State of New Jersey to operate a Deer Management Program; and

WHEREAS, it is necessary to formally acknowledge the acceptance of these grant funds and authorize the execution of the associated agreement with the State of New Jersey; and

WHEREAS, the Township Committee desires to designate an individual to execute said agreement and any subsequent amendments thereto, while ensuring compliance with all applicable Federal, State, and municipal laws, rules and regulations in performance pursuant to the agreement;

NOW, THEREFORE, BE IT RESOLVED by the Township Committee of the Township of Hopewell, in the County of Mercer, State of New Jersey, that:

1. The Township of Hopewell hereby acknowledges its entry into an agreement with the State of New Jersey for the purpose of operating a Deer Management Program and accepts the receipt of grant funds in the amount of Eight Thousand Two Hundred Fifty Dollars (\$8,250.00).
2. The Township of Hopewell agrees to comply with all applicable Federal, State, and municipal laws, rules, and regulations in its performance pursuant to the aforementioned agreement.
3. George Snyder, Administrator/Public Works Director, is hereby authorized to execute the agreement on behalf of the Township Committee of the Township of Hopewell.
4. George Snyder is further authorized to execute any amendments to said agreement without the requirement of additional approval from the Township Committee.
5. The Township of Hopewell acknowledges that it is not responsible for providing matching funds for this grant program.

BE IT FURTHER RESOLVED that a certified copy of this Resolution shall be forwarded to the State of New Jersey and George Snyder, Administrator/Public Works Director.
