**A RESOLUTION AMENDING A CONTRACT WITH GREENMAN-PEDERSEN, INC., (GPI) FOR A ZERO-DOLLAR AGREEMENT MODIFICATION REQUEST ASSOCIATED FOR THE CARTER ROAD EAST SEGMENT OF THE LAWRENCE HOPEWELL TRAIL (LHT)**

**WHEREAS**, the Township of Hopewell has entered into the NJDOT TAP Design Assistance Program to seek federal funding reimbursement for the required Preliminary Engineering (PE) and Final Design (FD) services associated with the design of a segment of the LHT on the east side of Carter Road (the "Project"); and

**WHEREAS**, the Township of Hopewell has received a grant agreement from the New Jersey Department of Transportation (NJDOT) under the 2016 Transportation Alternatives Program (TAP) for Preliminary Engineering Services for the Project; and

**WHEREAS**, NJDOT made available a Design Assistance Program to fund the design of the Project using federal funds and an approved engineering firm from a pool of firms established by NJDOT; and

**WHEREAS**, by Resolution #20-285, the Township of Hopewell and GPI entered into an Agreement (the "GPI Agreement") effective on September 17, 2020 to provide Preliminary Engineering Design Services for the Project; and

**WHEREAS**, the Township of Hopewell has received a TAP agreement modification from the NJDOT executed on December 28, 2022 to include Final Design Services in the amount of \$333,032.26 of additional funding for the Project; and

**WHEREAS**, by Resolution #23-60, the Township of Hopewell and GPI entered into an agreement modification with GPI, effective January 23, 2023, to include Final Design Services for the Project; and

**WHEREAS**, GPI has provided a Zero-Dollar Agreement Modification Request to reallocate funds within the existing Final Design phase of the project as approved by Resolution #23-60.

**NOW, THEREFORE, BE IT RESOLVED** that the Hopewell Township Committee of the Township of Hopewell hereby authorizes the mayor to sign a modification to the GPI Agreement for a Zero-Dollar Agreement Modification Request associated with the Project.
