Background

On occasion a resident abandons or fails to maintain their lawn properly, to the extent that it attracts unwanted wildlife and becomes a nuisance to neighbors. Hopewell Township ordinance permits violations and enforcements. When necessary the Township steps in, hires and pays an outside lawn service while placing a lien on the offender's property.

Scope of Work

Hopewell Township is seeking firm, fixed quotes from experienced landscape companies to provide lawn cutting services on an as-needed basis for the year 2018 with an option to renewal for one additional consecutive year if mutually agreed. Although the Township cannot guarantee the number of properties requiring these services, please know in 2017 (5) properties required lawn cutting services at a total cost of \$2,920.

Cuts

Violations begin at 10" in height. Lawn is usually around 24" before the Township can act. The Township understands the cost of the initial cut may exceed any routine cut due to excessive height of grass. Brush clearing equipment may be required. Therefore, when quoting each individual job the initial cut shall not exceed three times the cost of any routine cuts. Successful Contractor shall provide quote for initial cut to key contact for approval prior to proceeding. Township reserves the right to terminate these services at any time should the responsible party step forward.
