

Firetruck Use Agreement

This agreement, made this 17 day of JANUARY, 2021 by
and between:

Hopewell Township Fire District #1, (hereinafter referred to as
“Hopewell”) located at 201 Washington Crossing - Pennington Road
Titusville, NJ 08560; and **Plainsboro Township Fire District #1**, (hereinafter
referred to as “Plainsboro”) located at 407 Plainsboro Rd
Plainsboro, NJ 08536.

Whereas, Hopewell is the owner of the Firetruck, more specifically
referenced as a 1990 Peterbilt 357 Tanker firetruck, with a VIN of
1XPALBOX2LN299632 (hereinafter referred to as the “Firetruck”); and

Whereas, Plainsboro desires to utilize the Firetruck for the providing of fire
protection services.

Now, therefore, in consideration of the foregoing recitations and the mutual
covenants and promises hereinafter contained, the parties hereby agree as follows:

1. Plainsboro shall lease the Firetruck for a period of 1 years
commencing on January 17, 2021, and ending on January 31, 2022. Plainsboro shall
pay to Hopewell the sum of One dollar (\$1.00) for the Lease. The Lease shall
expire on January 31, 2022, unless renewed by mutual agreement of the Parties.
Plainsboro intends to utilize the Firetruck to provide fire protection services, until

such time as a new firetruck is purchased by Plainsboro and placed in service.

2. Plainsboro shall maintain, during the term of this Agreement, Automobile Liability coverage with a minimum combined single limit of \$1,000,000.00 and shall at all times maintain Comprehensive, Collision, Uninsured and Underinsured motorist coverage as required by Law. Hopewell shall be listed as an Additional Insured and a Loss Payee on all applicable Auto Insurance Policies.
3. Plainsboro, during the term of the Lease, shall be responsible for, and furnish all maintenance and repairs to keep the Firetruck in good working order and condition. Plainsboro shall be responsible for any damage to the Firetruck sustained during the term of the lease. At the expiration of the Lease, the Firetruck will be returned to Hopewell in good condition, with reasonable wear and tear excepted. The Firetruck shall not be altered, or marked, and no additional equipment shall be installed without prior written approval by Hopewell.
4. Plainsboro shall defend, indemnify and hold harmless Hopewell (including its agents, employees and officers) for and against any and all claims, damages, injuries, and expenses arising out of Plainsboro's use or operation of the Firetruck during the term of the Lease.
5. Either party may terminate this agreement at any time for any reason

or no reason, with or without cause, upon giving prior written notice to the other party specifying a termination date no sooner than thirty (30) days after such notice is delivered.

6. Notwithstanding the provisions of paragraph 5 above, the parties agree that during the term of the Lease, Hopewell may request a temporary suspension of the terms of the Lease (Temporary Suspension), and a return of the Firetruck, if Hopewell 's current Tanker is taken out of service. Upon Hopewell's current Tanker being restored to service, the Fire Truck will be returned to Plainsboro and all terms of the Lease will be restored. During the Temporary Suspension period all terms and responsibilities under the Lease will be suspended.

7. The terms and conditions set forth represent the entirety of the agreement between the parties.


As pertaining to current condition of Tanker 53-1

Chief I hope you are well.

As requested by the Hopewell Township Board of Fire Commissioners I can assure you that Tanker 53-1 is in top order and is fully operational. Our EVT certified maintenance company conducts PMs (Preventative maintenance) bi-annually and review of the tanker was completed by following all NFPA 1911 requirements. There was a slight air leak on the transfer valve and valve was replaced and confirmed in proper working order. The only thing we have found is a small water leak from the officers side of the water tank. This slight leak only occurs when tank is topped off and drips till tank is about 7/8s full. This leak does not in anyway effect the operation of this vehicle.

**Tanker 53-1 is fully operational and will serve you well.
