**RESOLUTION 2021-73**

**A RESOLUTION EXTENDING THE TERM OF THE FIRE PROTECTION SHARED  
SERVICES AGREEMENT WITH PENNINGTON BOROUGH FIRE DISTRICT #1**

**WHEREAS**, an Agreement for Fire Protection and Services (“the Agreement”) between Hopewell Township Fire District #1 (“the Township Board”) and Pennington Borough Fire District # 1 (“the Borough Board”) covering the period of January 1, 2016 through December 31, 2020, expired on December 31, 2020; and

**WHEREAS**, since its expiration both boards have continued to adhere to and operate according to the terms and conditions of the Agreement; and

**WHEREAS**, while they work to update the document both Boards desire to extend or renew the Agreement, all upon the same terms and conditions as contained in the expired Agreement, retroactive to January 1, 2021 and continuing through December 31, 2022.

**NOW, THEREFORE, BE IT RESOLVED**, by the Board of Fire Commissioners of Hopewell Township Fire District #1, County of Mercer, that an extension or renewal of the expired January 1, 2016 through December 31, 2020 Agreement for Fire Protection and Services between the Hopewell Township Fire District #1 and the Pennington Borough Fire District #1 hereby be authorized and approved, retroactive to January 1, 2021 and continuing through December 31, 2022, and upon the same terms and conditions as the expired Agreement, which is incorporated by reference and made a part of this Resolution as if fully set forth herein; and

**IT IS FURTHER RESOLVED** that the Board of Fire Commissioners of Hopewell Township Fire District #1 is authorized to take steps necessary to continue the relationship with the Pennington Borough Fire District #1 under the expired Agreement, including the execution of documents necessary or desirable, if any, to achieve this purpose.
